## TRANSITION PERIOD UNDER THE MYANMAR COMPANIES LAW ENDS ON 31 JULY 2019

The Myanmar Companies Law (2017) (MCL) fixes a transition period of twelve months before otherwise mandatory requirements or changes affecting then-existing entities take effect. This transition period ends on 31 July 2019. Therefore, by 1 August 2019:

- A private limited company registered under the Companies Act (1914) must have at least one director who is considered "ordinarily resident" in Myanmar, and a public company registered under the Companies Act (1914) must have at least one director who is a Myanmar citizen and who is also considered "ordinarily resident" in Myanmar. The MCL defines a person as "ordinarily resident" in Myanmar if he or she is a person who is a permanent resident of the Union under an applicable law or is resident in the Union for at least 183 days in each 12 month period.
- The "objects" (otherwise known as "business objectives" or "scope of business") of a private limited company or public company registered under the Companies Act (1914) are deemed to have been removed unless a notice in the prescribed form confirming the passing of a special resolution to maintain them is filed with the Registrar.
- Outstanding share warrants issued under the Companies Act (1914) are deemed to be surrendered and cancelled unless an extension has been applied for during the transition period.
- An appointment of a managing agent made under the Companies Act (1914) or during the transition period (including any extensions of such appointment) are deemed terminated, and the managing agent thus appointed shall thereafter be considered a director of the company.
